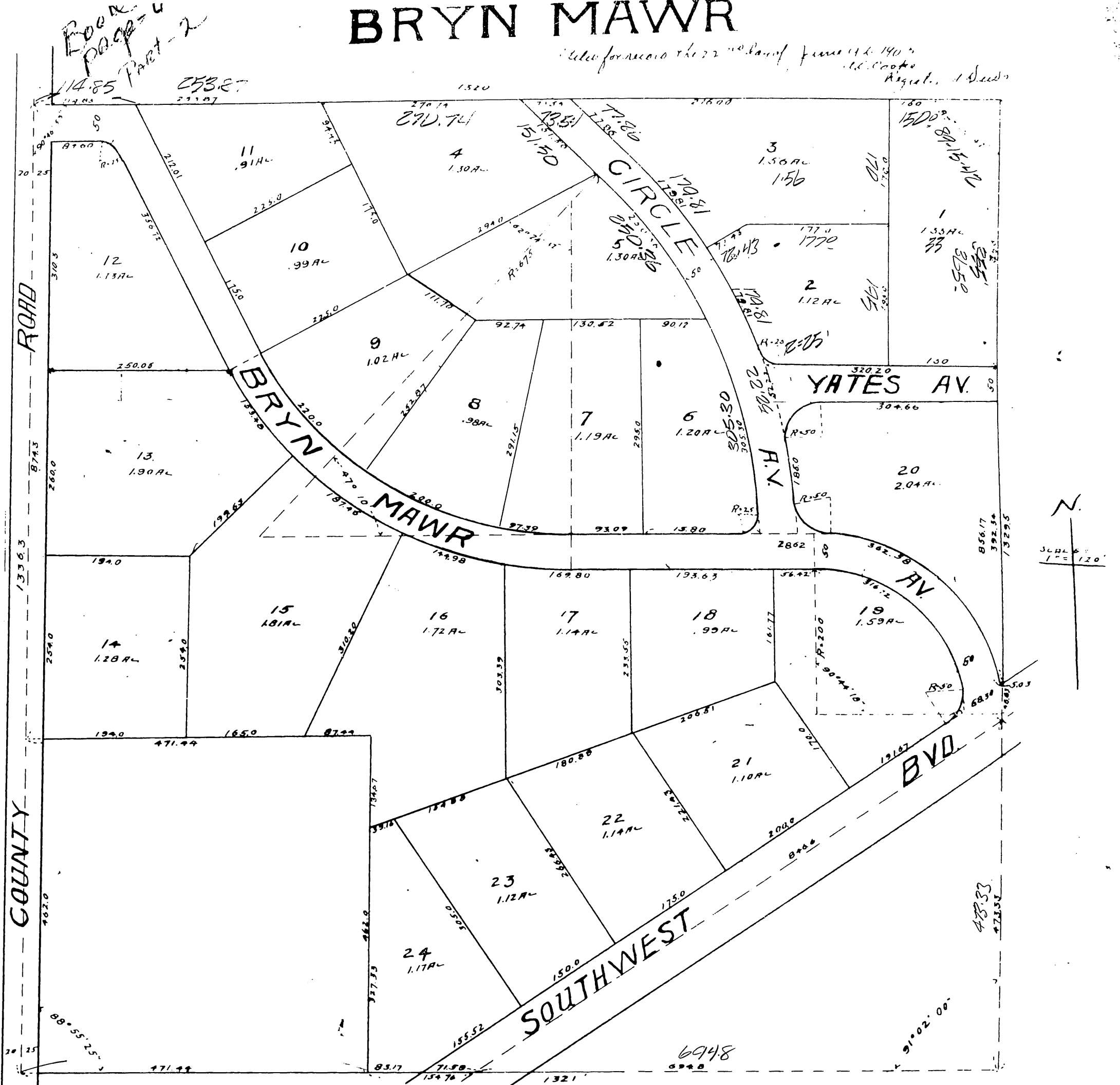

This is a subdivision of all that portion of the Southeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Thirty-Three (33) Township eleven (11) Range Twenty-five (25) in Wyandotte County, Kansas, described as follows: - Beginning at the North east corner of said Quarter (1/4) Quarter (1/4) Section, thence South along the East line of said Quarter (1/4) Quarter (1/4) Section, eight hundred and fifty six and seventy five hundredths feet (856.75) to the center line of the County Road, thence in a southerly direction along the center line of said County Road, eight hundred and fifty six and six tenths feet (856.6) to a point in the South line of said Quarter (1/4) Quarter (1/4) Section, which point is six hundred and ninety four and eight tenths feet (694.8) West of the Southeast corner of said Quarter (1/4) Quarter (1/4) Section, thence West along the South line of said Quarter (1/4) Quarter (1/4) Section, one hundred and fifty four and seventy six hundredths feet (154.76) to a point which is four hundred and seventy one and forty four hundredths feet (471.44) East of the Southeast corner of said Quarter (1/4) Quarter (1/4) Section, thence North along a line parallel to the West line of said Quarter (1/4) Quarter (1/4) Section, four hundred and twenty two feet (422) to a point, thence West along a line parallel to the South line of said Quarter (1/4) Quarter (1/4) Section, four hundred and seventy six and forty four hundredths feet (476.44) to a point in the West line of said Quarter (1/4) Quarter (1/4) Section, thence North along said West line eight hundred and seventy five and three tenths feet (875.3) to the Northwest corner of said Quarter (1/4) Quarter (1/4) Section, thence East along the North line of said Quarter (1/4) Quarter (1/4) Section thirteen hundred and twenty feet (1320) to the point of beginning, containing thirty one and six hundred and thirty four thousandths acres (31.634 ac.)

The undersigned proprietors of the above described tract of land have caused the same to be subdivided in the manner represented on the accompanying plat which subdivision and plat shall hereafter be known as Bryn Mawr.

The streets and avenues as represented on this plat are hereby dedicated to public use forever.
