


KERR & WOOLARD

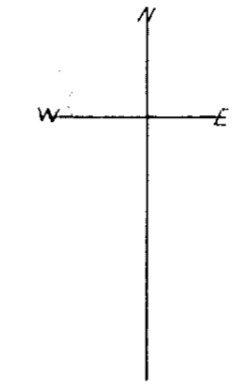
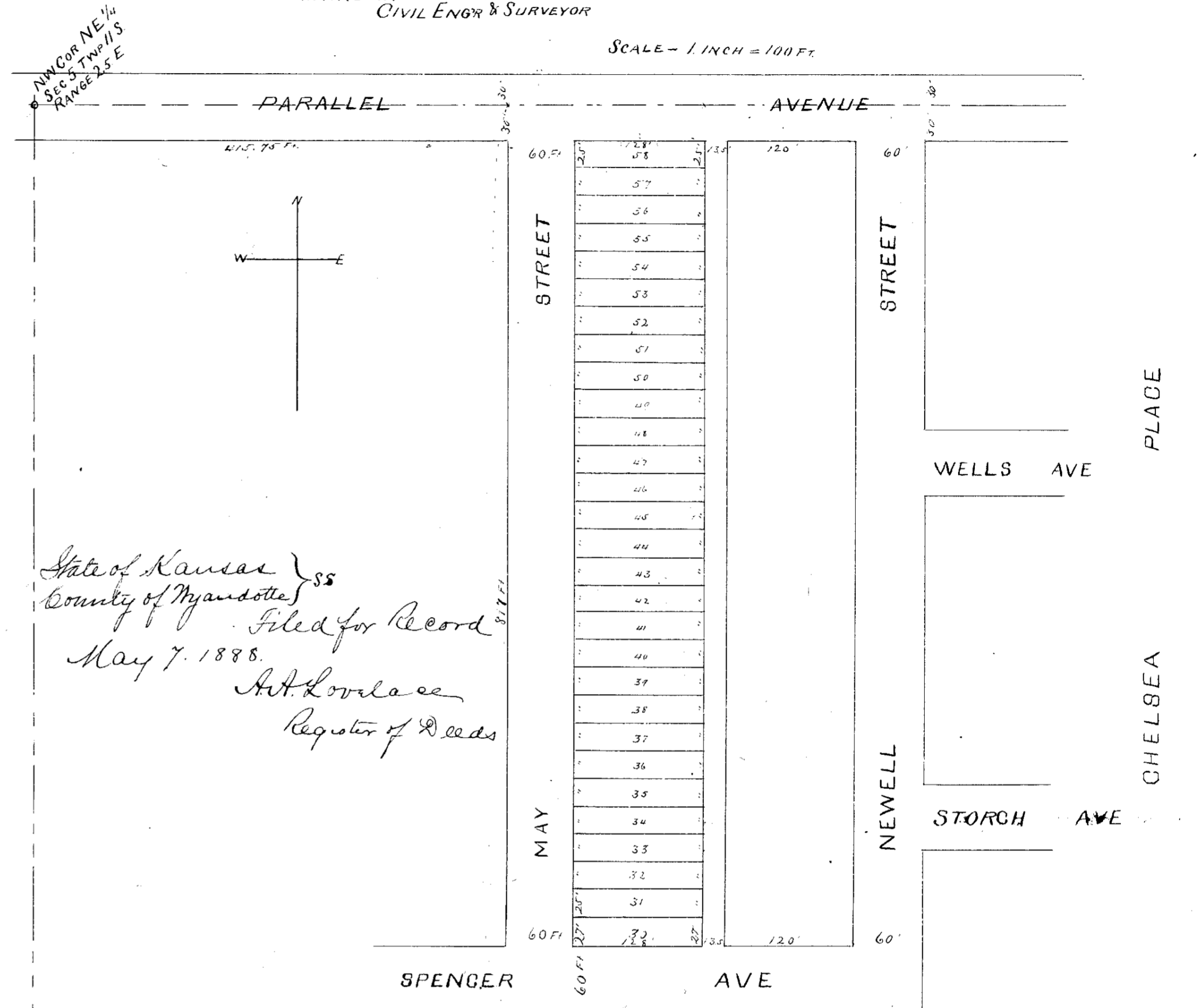
