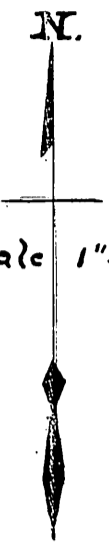
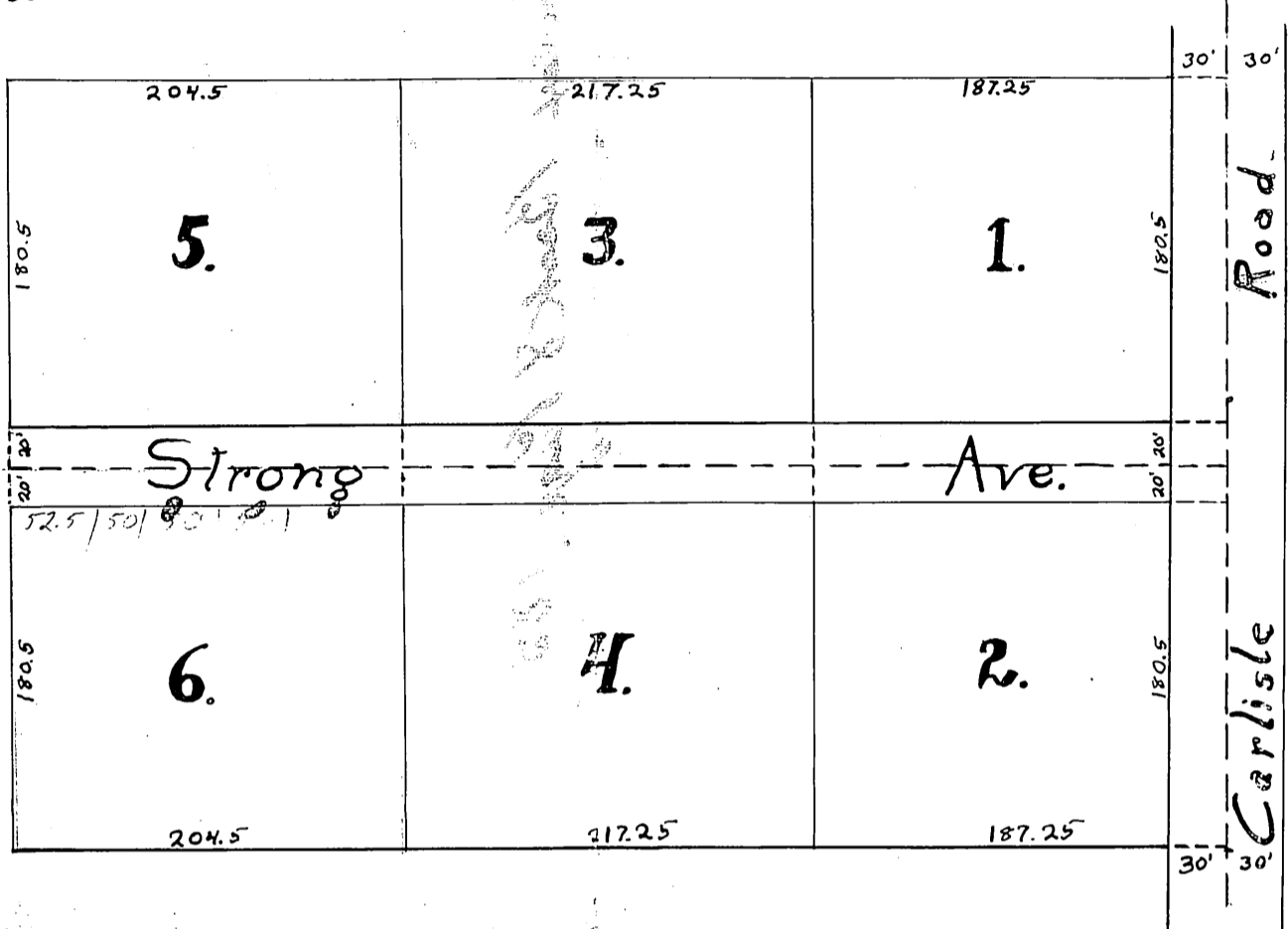


PLAT OF CHERRY ORCHARD ADDITION IN S.W. 1/4 Sec. 19-11-25 Wyandotte County

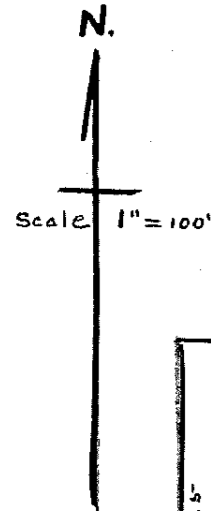

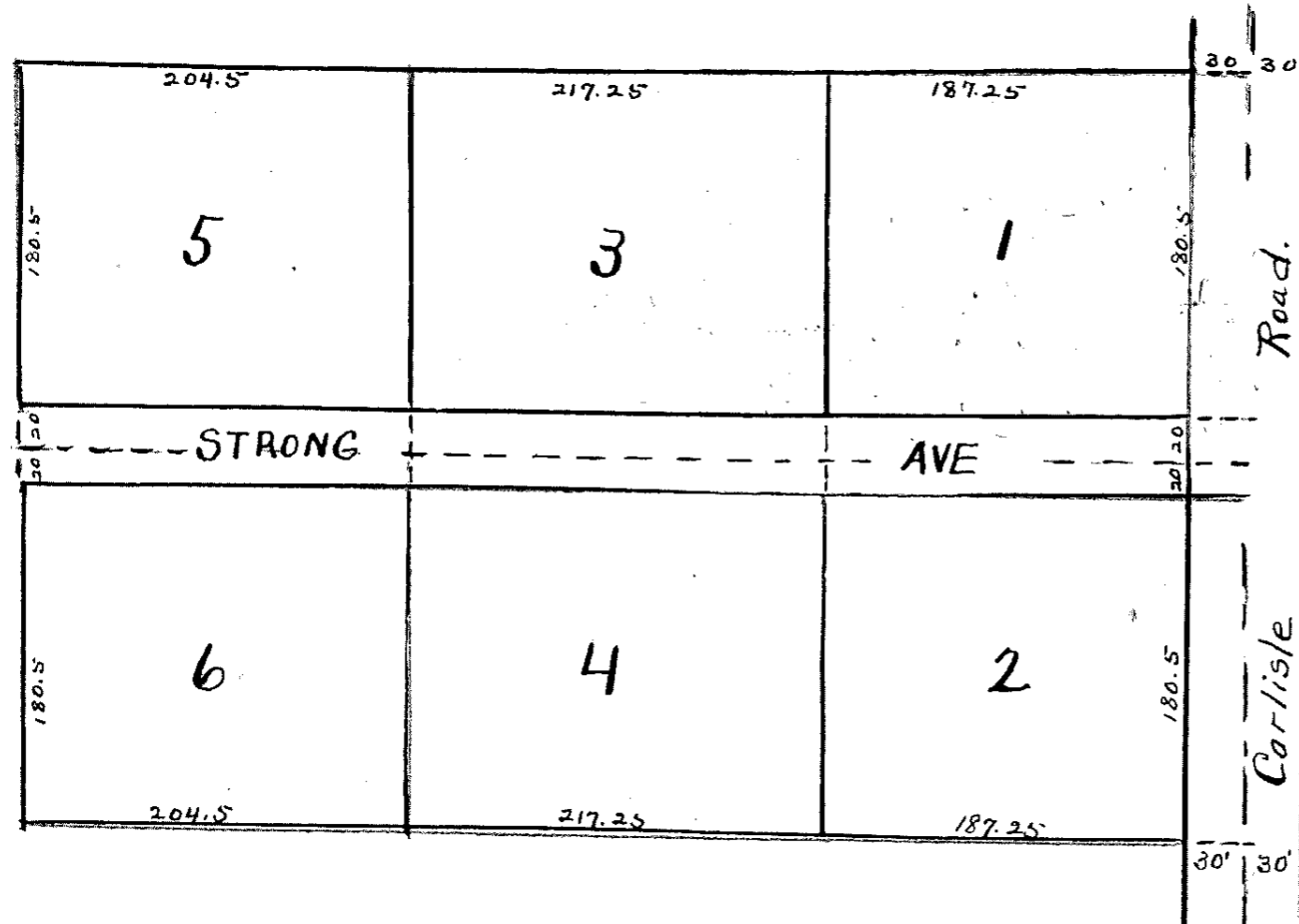
