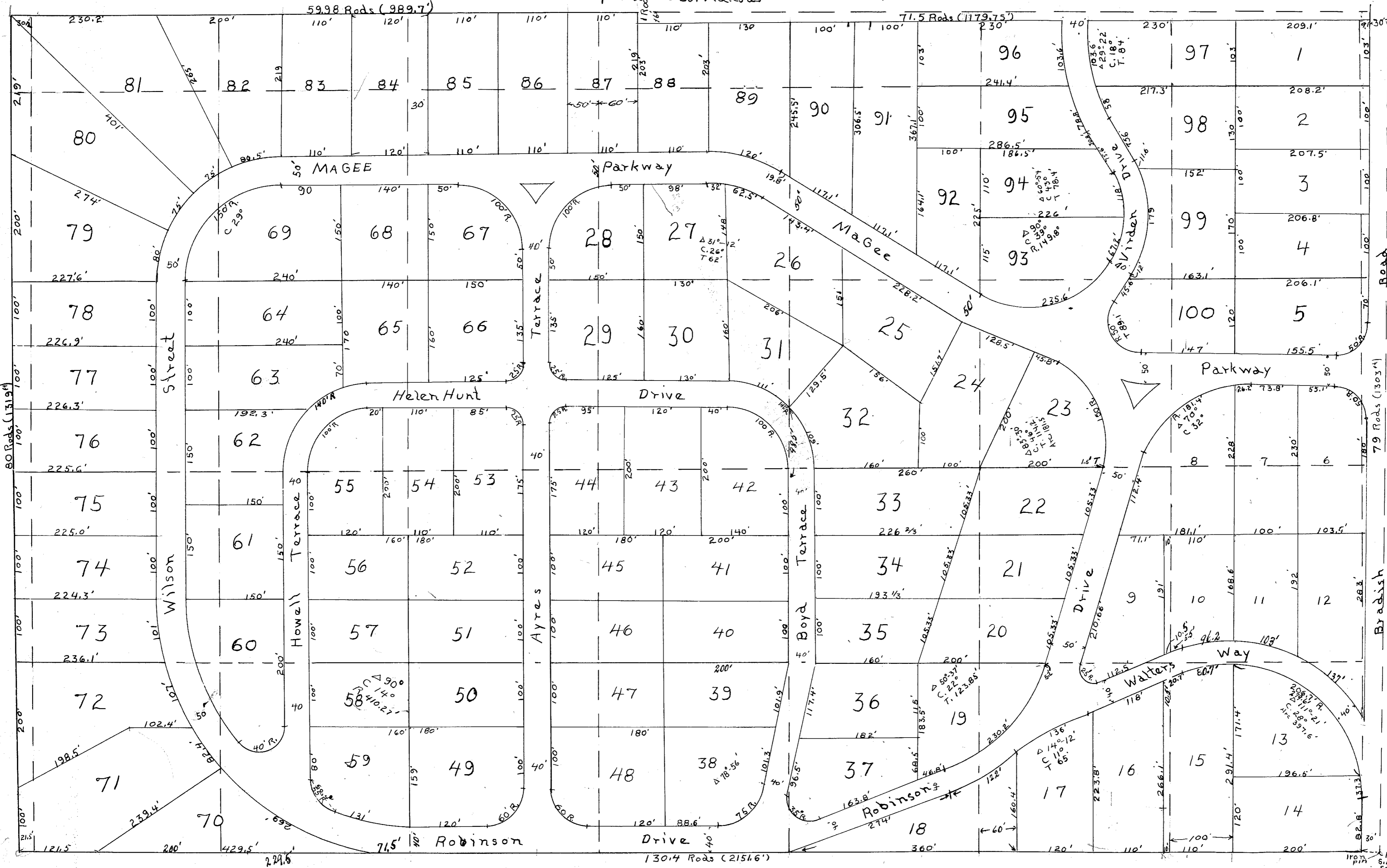


PLAT OF COMBS - PARK
