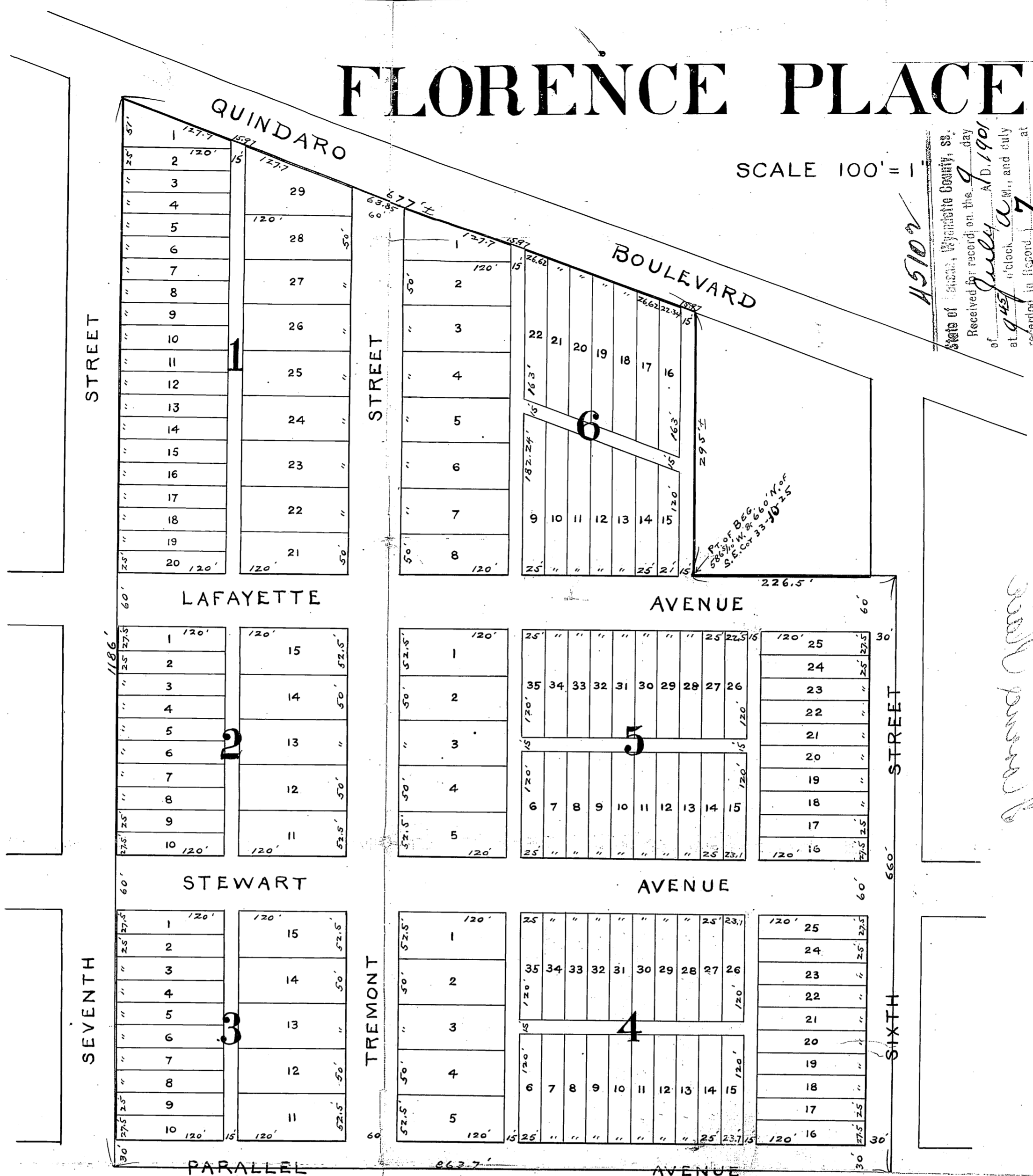


FLORENCE PLACE

Handwritten note: Florence Place

This Plat of Florence Place covers land in Wyandotte County Kansas, thus described to wit:—

Beginning at a point 586 2/3 feet west and 660 feet north of the south east corner of section 33—Township 10 South—Range 25 East, said point being on the north line of Lafayette Avenue produced from the west; thence east on said north line of Lafayette Avenue 226 1/2 feet to the center line of Sixth Street produced from the south; thence south along said center line of Sixth Street, 660 feet to the south line of said section 33; thence west along said south line of section 33, 863 2/3 feet to the east line of Seventh Street; thence north along said east line of Seventh Street 1186 feet to the south line of Quindaro Boulevard; thence southeasterly along said south line of Quindaro Boulevard 677 1/2 feet to a point due north of beginning, thence south 295 feet to point of beginning.

The lands reserved for sale are described, by numbers, as blocks and lots in Florence Place; the blocks being numbered with large, and the lots with small figures. The parcels of ground in this subdivision reserved for public use are streets, avenues and alleys. The names, extent and direction of such streets, avenues and alleys are designated on this plat and they are hereby dedicated to public use as such.

In testimony whereof The Barker Place Land Company, proprietors of said Florence Place, causes this plat to be signed by its president and Secretary and its common and corporate seal to be hereto affixed this 2nd day of July, 1901.
