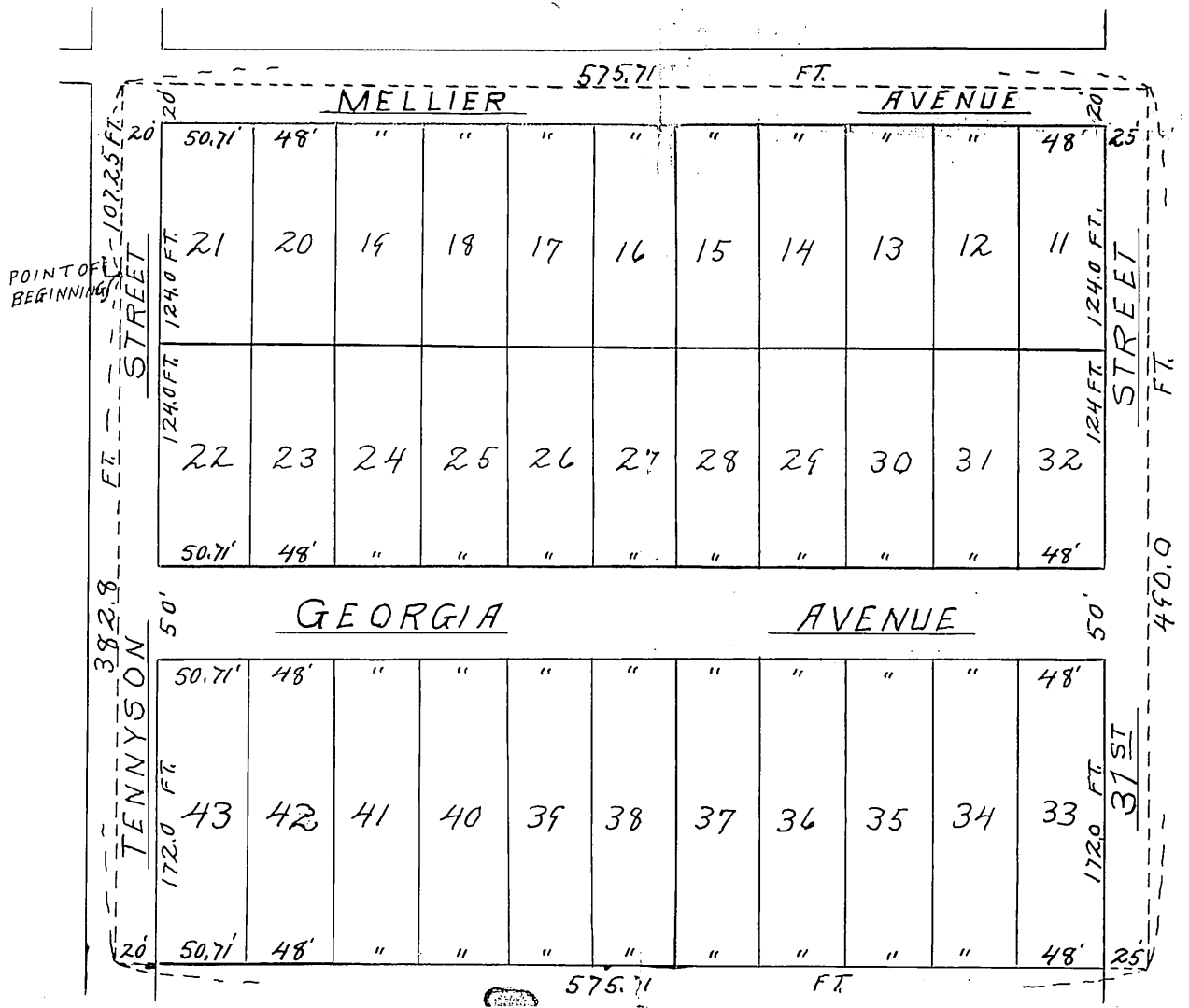


FREDERICK HEIGHTS
