KNOW ALL MEN BY THESE PRESENTS THAT J. T. WALLACE AND HIS WIFE G. A. WALLACE OWNERS OF THE FOLLOWING

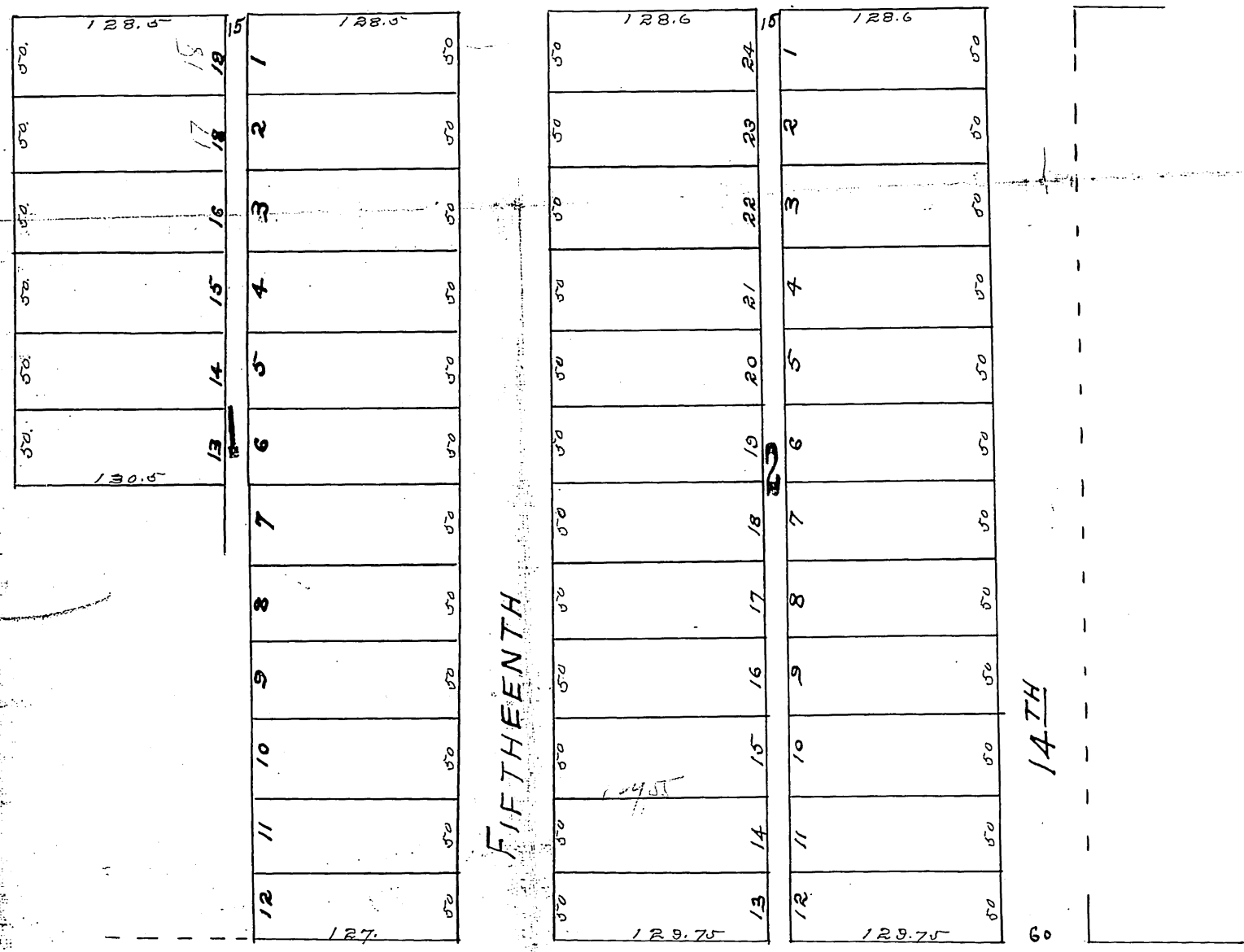
