



Industrial Addition

This Plat of INDUSTRIAL ADDITION covers land in Wyandotte County Kansas, described as follows:—Beginning at a point in the North line of Section 27 in Twp. 11 S. of R. 25 E. 380 ft. East of the North West corner of the North East quarter of said Section; thence N. 11° 00' E. 422.8 ft.; thence N. 45° 30' E. 396.6 ft.; thence East along the North line of the Shawnee Reserve 1700 ft.; thence South 695 ft.; thence West 1024.5 ft. to the North East corner of the North West quarter of the North East quarter of said Section; thence South 214.1 ft.; thence N. 65° 00' W. 162 ft.; thence N. 58° 00' W. 74 ft.; thence Northwesterly on a curve to the right with a radius of 231 ft. a distance of 127.5 ft.; thence West along said Section line 135.6 ft.; thence S. 16° 44' E. 411.7 ft.; thence S. 16° 55' W. 26.1 ft.; thence W. 31.4 ft.; thence S. 16° 55' W. 35.8 ft.; thence S. 61° 11' W. 55.3 ft.; thence N. 30° 13' E. 397 ft.; thence N. 11° 00' E. 167 ft. to the point of beginning.

The lands reserved for sale are lots and blocks, the lots being numbered in small figures and "A" and the blocks in large figures, the exact size and dimensions of which are shown, and they will hereafter be known as lots and blocks in INDUSTRIAL ADDITION. The parcels of ground intended for public use are streets, avenues, roads and alleys, the name, extent and direction of which are shown on this plat and they are hereby dedicated to public use as such.
