## DOUGLAS AVE

Know all men by these presents that we Geo W Doohaker and Isabella Doohaker his wife joint-owners of Isabella Place an Addition to Wyandotte County Kansas have caused to be made the accurate plat or map annexed hereto attached and that the description of all parcels of ground within such addition as hereinafter mentioned is correct and that the description of all Lots intended for sale by number length and width is precise and accurate as follows to wit: The above named addition is situated in the County of Wyandotte and State of Kansas described as follows. Beginning at a point ten (10) feet due west of the South east corner of the North east quarter of Section number thirty (30) Town number Eleven (11) and Range number Twenty five (25) East, thence West Three Hundred and seventeen (317) feet thence North Thirteen Hundred and thirty (1330) feet thence East Four Hundred and two (410) feet to center of Wyandotte Shawnee wagon road thence South along center of said road to place of beginning said addition is divided into Eleven (11) and Lots. The Eleven (11) are dedicated to the Public and for the use of the public while the Lots are reserved and intended for sale. Hawley Avenue is thirty (30) feet wide and runs along the North side of said Addition, Lola Avenue is thirty (30) feet wide and runs along the east side of said addition, Douglas Avenue is fifteen (15) feet wide and lies along the south side of said addition, Mary Avenue is twenty (20) feet wide and extends along the West side of said Addition, while Lawrence Avenue is six (6) feet wide and extends East and West between Blocks numbered one (1) and two (2). The Lots in Block numbered one (1) are numbered from one (1) to Fifty eight (58) inclusive and in Block number two (2) from one (1) to Fifty (50) inclusive which together with their lengths and widths is shown upon the plat.
