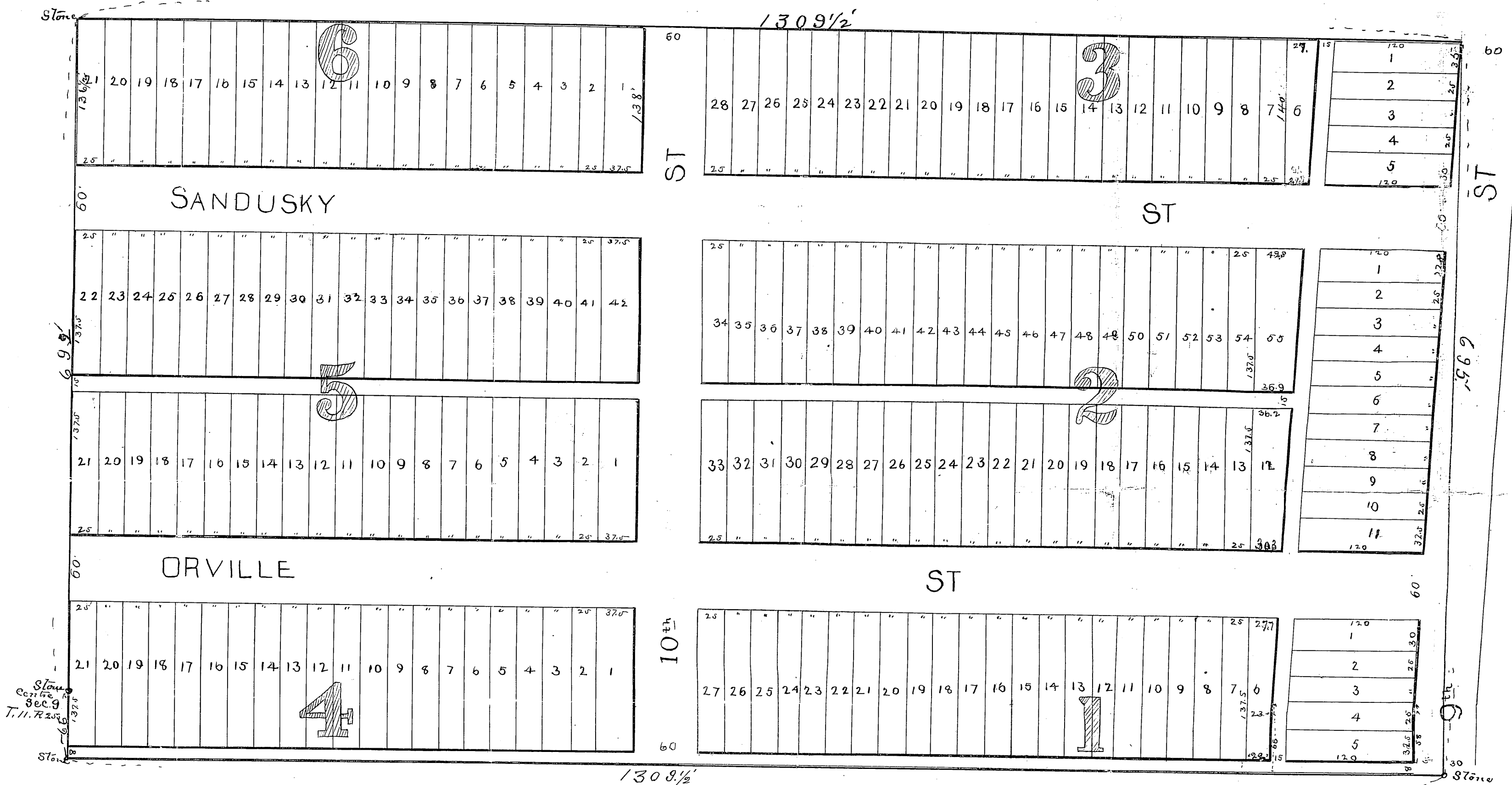


# NORTHROP PARK

This Plat of Northrup Park covers land in Wyandotte County, Kansas thus bounded to wit:-

Commencing at a point sixty six (66) feet South of the center of Section nine (9) Township eleven (11) South and Range Twenty five (25) East Thence North Six hundred and thirty two (632) feet to South line of alley in Block 168 & 169 in Wyandotte City as per record, Thence East Thirteen hundred and nine and one half (1309 1/2) feet along South line of said alley Thence South Six hundred and ninety five (695) feet to a point due east of beginning Thence West thirteen hundred and nine and one half (1309 1/2) feet to the beginning

The lands reserved for sale are described by numbers as Blocks and Lots in Northrup Park the blocks being numbered with large blue figures and Lots in small black figures. The parcel of ground in the subdivision reserved for public use are Streets and alleys. The names, extent and direction of all such Streets and alleys are designated on Plat and such Streets and alleys are reserved and dedicated for public purposes as such.

All Lots intended for sale are set forth and described by numbers in blocks, the precise length and width of each Lot in feet and decimal portions thereof is set forth on this Plat in small black figures.
