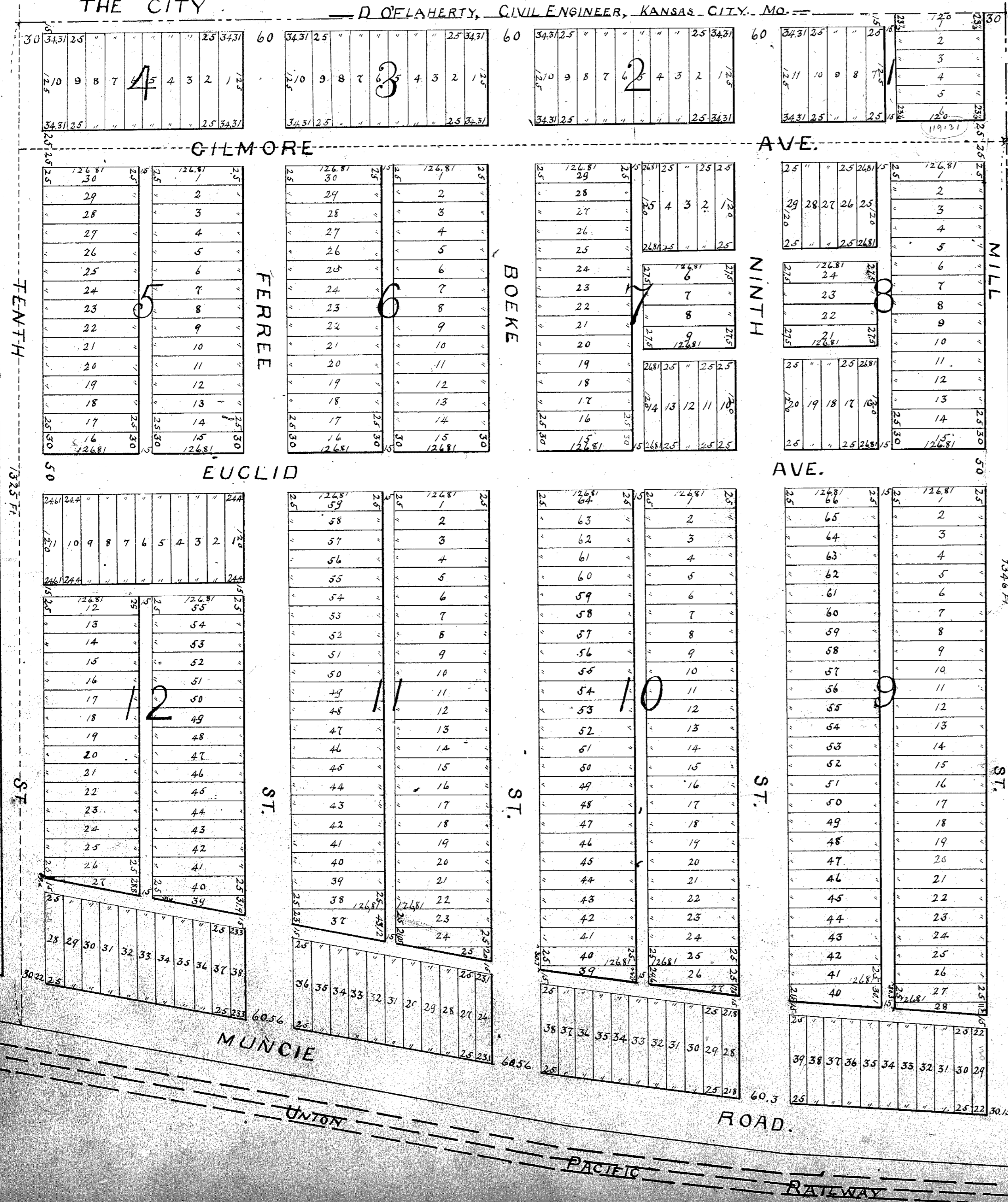


# SPLITLOG PARK.

A SUBDIVISION OF LAND IN THE CITY OF KANSAS CITY KANSAS.

Be it known that the undersigned, the Wyandotte Land Company a Corporation duly incorporated under the Laws of the State of Kansas and proprietor of the following described real Estate, does hereby subdivide said real Estate situated in the City of Kansas City, in Wyandotte County, State of Kansas, and described by notes and bounds as follows to wit: Commencing at North-East Corner of the South-East quarter of Section 16, (sixth) Township 11 (Eleven) South, Range 25 (Twenty-five) East of the sixth principal Meridian, thence North 165 Feet, thence west and parallel with the North line of the South-East quarter of said Section 16 to the center of 10th Street as the same is located in the said City of Kansas City, thence South with the center line of said 10th Street, 1325 feet to the north line of the right of way of the Union Pacific Railway, thence eastward with the north line of said right of way to the East line of South-East quarter of said Section 16, thence North with the East line of said quarter Section, 1346 ft, more or less to the beginning, and has caused and does hereby cause the same to be laid out into Lots, Blocks, Arches, Streets and Alleys and area, as designated upon the above plat, and the same shall hereafter be known as Splitlog Park, that in said plat is designated the ground that is reserved for public purposes, for Streets, Arches, Alleys and road and the boundaries, course and extent thereof, the same being brown color, and that the Lots and Blocks intended for sale are designated on said plat by numbers, and their precise length and breadth on given portion, and the said proprietor does hereby dedicate the said streets, streets, alleys and road, marked and designated and colored brown on said plat to public use for highways forever.

In witness whereof, the said proprietor, the Wyandotte Land Co, a Corporation as aforesaid has caused these presents, to be signed by its President, and its Corporate seal hereto, affixed this 27th day of Dec. 1892.
