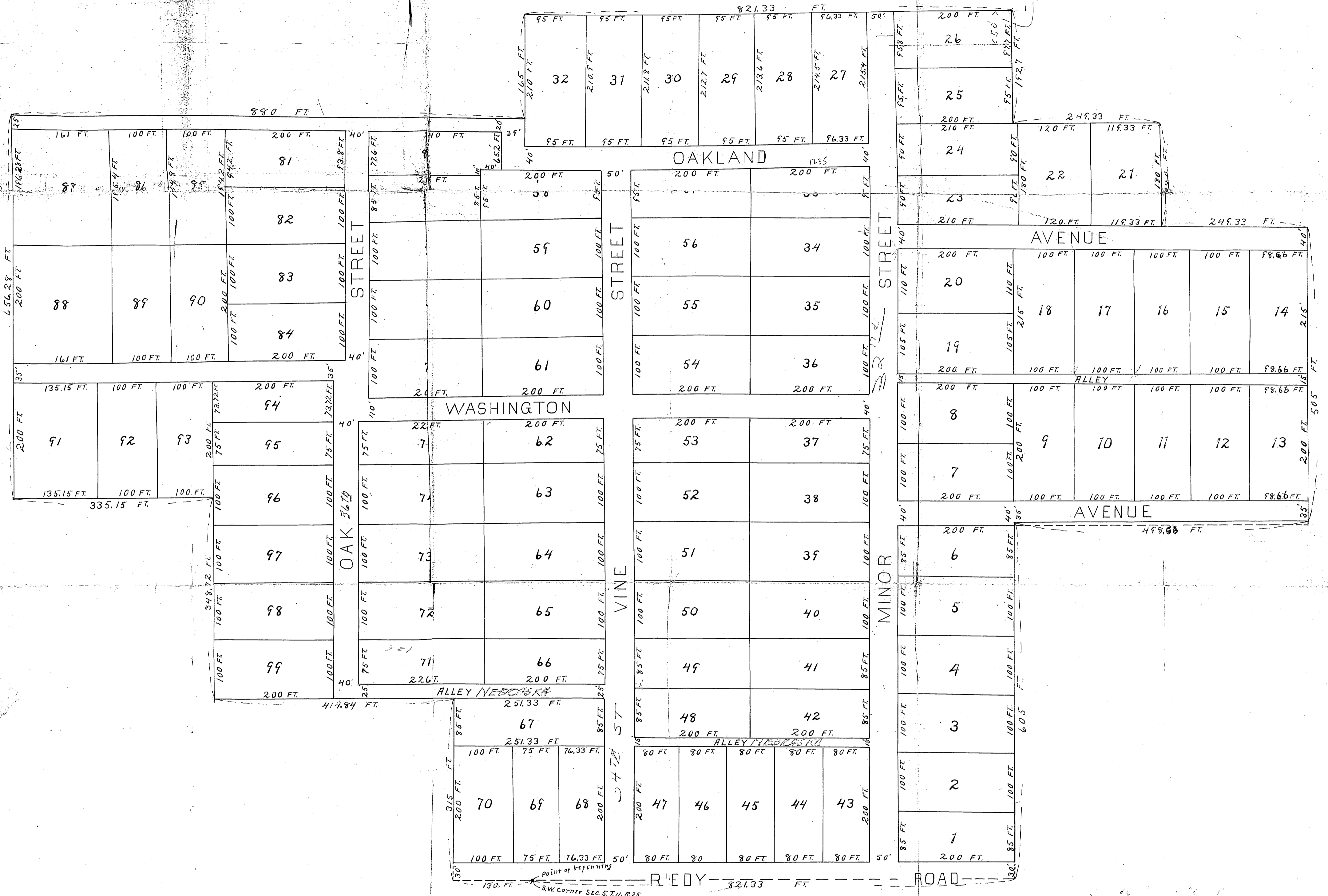
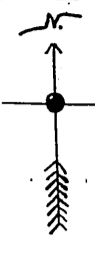


WOODLAND PARK

This Plat of WOODLAND PARK covers land in Wyandotte County, Kansas, described as follows, to-wit:-
 Beginning at the southwest corner of Section 5, Township 11, S., Range 25, E.; Thence west one hundred-thirty (130) feet; Thence North three hundred fifteen (315) feet; Thence West four hundred fourteen and eighty-four hundredths (418.84) feet; Thence North three hundred forty-eight and seventy-two hundredths (348.72) feet; Thence West three hundred thirty-five and fifteen hundredths (335.15) feet; Thence North six hundred fifty-six and twenty-eight hundredths (656.28) feet; Thence East eight hundred eighty (880) feet; Thence North one hundred sixty-five (165) feet; Thence East eight hundred twenty-one and sixty-three hundredths (821.33) feet; Thence South one hundred ninety-two and seven tenths (192.7) feet; Thence East two hundred forty-nine and thirty-three hundredths (249.33) feet; Thence South one hundred eighty (180) feet; Thence East two hundred forty-nine and thirty-three hundredths (249.33) feet; Thence South five hundred five (505) feet; Thence West four hundred ninety-eight and sixty-six hundredths (498.66) feet; Thence South six hundred five (605) feet; Thence West eight hundred twenty-one and thirty-three hundredths (821.33) feet to the point of beginning.

The lands reserved for sale are designated, by numbers from 1 to 99 inclusive, as tracts in WOODLAND PARK, the location and exact size of each and every tract is shown upon the accompanying plat and reference is made thereto. The parcels of ground reserved for public use are Streets, Avenues, Alleys and Road the names, extent and direction of all Streets, Avenues, Alleys and Road are designated on the accompanying plat, and they are hereby dedicated to public use as such.
